Litmus test for Revanth as '100 days' near

With deadline on March 17, several components of Six Guarantees yet to be grounded

Chief Minister A Revanth Reddy has repeatedly been assuring the people in almost every meeting that he is a man of his word, and that every promise his party made prior to the Assembly elections would be kept.
With just seven days left for the 100-day timeframe

Revanth Reddy set for his government to implement its poll promises, the next one week will be a test of the government's commitment levels. Interestingly, a major portion of the multiple components of the Six Guarantees (Abhaya Hastam) are yet to be grounded. So far, two of three components of Maha Lakshmi, the first of six guarantees, have been launched — LPG cylinders at Rs 500 and free travel for women in RTC buses.

The second guarantee of Rythu Bharosa of Rs 15,000 per acre to farmers and Rs 12,000 to agricultural labour every year is still on paper, while the third guarantee, Gruha Jyothi scheme with 200 units of free electricity, has been launched, albeit with riders that flush out a

large number of beneficiaries. The fourth, Indiramma Housing, is set to be launched on Monday, while the second part of the same guarantee, house yards of 250 square yards for Telan-gana movement fighters, is vet to be launched.

Yuva Vikasam, the fifth guarantee is also still on paper, while Cheyutha, the

sixth guarantee, has only one of two components, that of hiking the Rajiv Aro-gyasri health insurance being hiked from Rs 5 lakh to Rs 10 lakh, launched so far. Several other promises, right from the Warangal Rythu Declaration and the Hyderabad Youth Declaration to the Chevella SC/ST Declaration, the Minority Declaration and the Kamareddy BC Declaration, all remain promises.

Though the State government has been claiming credit for the recent job opportunities, it is a known fact that the appointment letters Revanth Reddy handed over to candidates were the last step of the recruitment process initiated by the previous BRS government. With just seven days left for all these to be launched, BRS working president KT Rama Rao on Sunday demanded the implementation of the six guarantees promised by the Congress within the 100-day timeframe, which concludes on March 17. If the promises are not delivered in time, BRS will launch a people's movement against the Congress, he said. (SEE PAGE 2)

Swiss watches, chocs to cost less

India to phase out customs duties under \$100-billion EFTA pact

NEW DELHI

Domestic customers will get access to high-quality Swiss products such as watches, chocolates, biscuits and clocks at lower prices as India will phase out customs duties under its trade pact with the EFTA bloc on these goods over a period of time.

India and the four-European nation bloc EFTA signed a trade and economic partnership agreement (TEPA) on Sunday to boost trade and investments between the two regions.

Under the free trade agreement, New Delhi has received an investment commitment of \$100 billion over the next 15 years to facilitate the creation of one million jobs.

The European Free Trade Association (EFTA) mem-

NEW DELHI: Prime Minister Narendra Modi on Sunday said the signing of the trade agreement between India and the four-nation European bloc EFTA is a "watershed moment" as it symbolises a shared commitment to open, fair and equitable trade. bers are Iceland, Liechtenstein, Norway and Switzerland. It will take up to a year to implement the agreement

due to an elaborate ratification process of these pacts in different countries. "We are giving duty concessions on Swiss watches and chocolates," an official said. Some famous Swiss watch brands are Rolex, Omega and Cartier. Nestle, which is a Swiss brand, is a major player in the Indian FMCG industry and manufactures chocolates in India. It is the third-largest listed entity in the Indian FMCG segment.

According to an analysis of the TEPA documents by economic think tank Global Trade Research Initiative (GTRI), India has allowed tariff concession to a number of products imported from Switzerland under the pact. "India will soon have access to high-quality Swiss products at lower prices as it has decided to remove tariffs on many Swiss goods over seven to 10 years," GTRI founder Ajay Srivastava said.

2 new ECs likely by March 15

NEW DELHI

Two Election Commissioners (ECs) are likely to be appointed by March 15 to fill the vacancies created by the retirement of Anup Chandra Pandey and the surprise resignation of Arun Goel, sources said on Sunday. Days before the poll panel

is expected to announce the schedule for the Lok Sabha polls, Goel resigned on Friday morning. His resignation was accepted by President Droupadi Murmu on Saturday and the Law Ministry issued a notification to announce it. This leaves Sources say Arun Goel may have quit due to personal reasons, reject claims of differences with Rajiv Kumar

Chief Election Commissioner Rajiv Kumar as the sole member of the poll authority. Pandey had demitted office on February 14 on attaining the age of 65 years.

Wine dealers left high and dry

An apparent lack of communication and coordination between government departments is allegedly leading to harassment of wine dealers in Telangana.
The issue arose with the
Commercial Tax Depart-

ment insisting on e-way

bills from the dealers and the Excise Department, which has to issue the e-way bill, not doing the same. Using the pretext of the absence of e-way bills, Commercial Tax officers are alintercepting vehicles carrying liquor to wine shops and seizing them. The vehicles were being held at police stations, with the "harassment" affecting the entire liquor trade in the State, wine deal-

Generally, e-way bills are issued by a wholesaler or distributor to a retailer on the purchase of any goods. In this context, if the e-way bill is made mandatory for wine dealers, the Excise Department has to issue the same to dealers as they purchase stocks from the department depots after paying the requisite amount, Telangana State Wine Dealers Association president D Venkateshwara Rao said.

While purchasing stocks from the Excise Department, dealers pay all taxes, including Special Excise Cess and TCS. Only after this is paid, they can download bills and transport permits for vehicles to shift the stocks, he said. "Since wine dealers sell the stocks to consumers in retail, why should we obtain the e-way bill?" Rao argued. (SEE PAGE 2)

Work up an appetite, it's time for haleem!

The month of Ramzan is around the corner and restaurants across the city are all geared up to prepare and offer mouth-watering haleem.

Ubiquitous during Ramzan, haleem attracts people from all walks of life to restaurants that spend eight to nine hours preparing the dish, which originated in Iran. It was first introduced to the city by Madina Hotel located

in the Madina Building, Old City, and gradually other restaurants started preparing it during

Ramzan. Haleem is prepared using chicken, mutton or beef meat, ghee, wheat, spices, dry fruits

and other ingredients. A plate of mutton haleem is priced between Rs 220 and Rs 270 in Hyderabad. Mohd Majeed, the

owner of Pista House, said the cost of ingredients has increased significantly in the last one year and wages of workers and transportation cost too have shot up. "Nevertheless, we are not going for a major hike. A decision on the price will be taken in a day or two and we assure it will not affect our customers," he told Telangana Today.

Lemon sold for Rs 35,000

A single lemon fetched Rs 35,000 at an auction held at a private temple in a village near here, the temple authorities said.

As per custom, the lemon and other items, including fruits offered to Lord Shiva during Mahasivarathiri at the Pazhapoosaian temple near Sivagiri village, 35 km from here, were auctioned. Fifteen devotees participated in the auction and a lemon was sold to one of them for Rs 35,000. PTI
