The Union Budget presented for a record seventh time by Union Finance Minister Nirmala Sitharaman saw key NDA allies — TDP, led by N Chandrababu and the Nitish-Naidu

Kumar's JD (U) - being accorded a 'special' treatment. Announcing a host of developmental projects, Sitharaman proposed a total outlay of over Rs 60,000 crore for various projects in Bihar, which is due for Assembly polls next year, and Rs 15,000 crore this fiscal for the development of Andhra Pradesh's capital city Amaravati, a dream project of Chief Minister Naidu.

The support to Bihar is in the form of capital projects, not a subsidy or cash dole. For Andhra Pradesh, the allocation of Rs 15,000 crore in financial aid is through multilateral agencies.

A similar request for support to Bihar will also be expedited, she said. The Fi-Minister nance also announced income tax relief for the middle class, a Rs 2 lakh crore outlay for job creation schemes over the next five years as she unveiled Modi 3.0 government's first Budget after the general

elections. With rural distress and unemployment being blamed for BJP losing its majority, Sitharaman in the Budget provided Rs 2.66 lakh crore for rural development and maintained spending on long-term intrastruc ture projects at Rs 11.11 lakh crore to boost economic growth. She abolished angel tax for all classes of investors in startups, cut customs duty on mobile phones and gold and simplified capital gains tax. She, however, raised the securities transaction tax (STT) on futures and options of securities, which led to tanking of stock markets. "In this budget, we particularly focus on employment,

Sitharaman on Tuesday hiked the standard deduction by 50 per cent to Rs 75,000 and tweaked tax slabs under the new income tax regime to provide more money in the hands of the salaried class with a view to boost consumption. She said salaried employees in the new tax regime could save up to Rs 17,500 in income tax annually following the changes announced in the Budget.

SC: No retest, cancellation of NEET-UG

NEW DELHI

In a major setback to unsuccessful aspirants of NEET-UG, the Supreme Court dismissed pleas seeking cancellation and re-test of the exam, holding that there was no evidence on record to conclude that it was "vitiated" on account of "systemic breach" of its sanctity. A Bench comprising Chief Justice DY Chandrachud and Justices JB Pardiwala, Manoj Misra concluded the four-daylong proceedings where they heard submissions from a battery of lawyers.

Referring to its independent scrutiny of the data placed by NTA and others, the CJI said, "At the present stage, there is absence of material on record to lead to conclusion that the result of exam is vitiated or that there is systemic breach of the sanctity of the exam." The data on record is "not indicative of a systemic leak of the question paper which would indicate a disruption of the sanctity of the examination," the Bench said. PTI

Raw deal for TS, big push for AP

Govt honours promises made under AP Reorganisation Act for Andhra, ignores TS

Telangana has found no mention in the Union Budget for 2024-25 presented in Parliament on Tuesday. While it did not surprise many, what was appalling was the Central government honouring the promises made under the Andhra Pradesh Reorganisation Act for Andhra Pradesh but not Telangana. None of the requests from the State government were accommodated in the Union Budget.

In her Budget speech, Union Finance Minister Nirmala Sitharaman had nothing to offer for the State except the Hyderabad-Bengaluru Industrial Corridor, which was targeted to largely benefit the Rayalaseema region of Andhra Pradesh.

Not so surprisingly, Sitharaman showered gifts and special packages for Andhra Pradesh led by its ally TDP, including funds to fulfil the provisions of the AP Reorganisation Act. Speaking in Parliament, she said concerted efforts would be made to fulfil the commitments under the AP Reorganisation Act, but allocated specific funds only to Andhra

Pradesh, ignoring Telangana's needs. "Rs 15,000 crore will be arranged in the current financial year to develop Andhra Pradesh's capital. Grants for backward regions will be provided to three districts as per the AP Reorganisation Act," she said, fulfilling the wish list of Andhra Pradesh Chief Minister N Chandrababu Naidu. She promised to grant more funds for capital development in

future. The Union Finance Minister also declared that the Centre was fully committed to fund and complete the Polavaram project, terming it as crucial for food security. She also promised special assistance for the development of industrial nodes along the Visakhapatnam-Chennai Industrial Corridor, besides infrastructure development for Orvakallu and Kopparthi industrial areas in Andhra. However, she did not quantify the amount of funds.

In the last 10 years, the previous BRS government submitted numerous representations to the Centre to fulfil around 35 promises made to Telangana under the AP Reorganisation Act. However, there has been no response. Though the Centre sanctioned Tribal University at Mulugu last year, no additional funds were allocated this year. Neither the steel plant at Bayyaram nor the railway coach factory at Kazipet which were part of the Act, received any funds. Similarly, national project status for irrigation projects such as the Palamuru-Rangareddy Lift Irrigation Scheme was also denied and requests for Central institutes like IIM were ignored. 'No mention of Telangana at all'

BRS working president KT Rama Rao expressed strong disappointment over the Union Budget, stating that despite high expectations, Telangana was once again neglected. "We hoped that Telugu daughter-inlaw, union Finance Minister Nirmala Sitharaman, would allocate significant funds to Telangana. But what we got is nothing," he stated in his response to the union Budget for 2024-25. He highlighted that despite the Central Budget exceeding Rs 48 lakh crore, only a few States received major benefits, with Telangana not being mentioned at all.

The BRS working president recalled how former Chief Minister K Chandrashekhar Rao made numerous requests to the union government to support the young State of Telangana and fulfil 35 promises made under the Andhra Pradesh Reorganisation Act. However, there was no response in the last ten years. He pointed out that there were no additional funds for the proposed Tribal University at Mulugu, the promised steel plant at Bayyaram or the railway coach factory at Kazipet. (SEE PAGE 2)


