

Revanth's incompetence led to Sunkishala incident: KTR

Demands judicial probe into the incident and action against those responsible

STATE BUREAU HYDERABAD

BRS working president KT Rama Rao held Chief Minister A Revanth Reddy responsible for the collapse of the retaining wall of the under-construction intake well and pumphouse complex at Sunkishala project at Nagarjuna Sagar. Terming it as a result of Revanth Reddy's incompetence as the Municipal Administration Minister, he demanded that a judicial probe be conducted into the incident and action be initiated against those responsible.

Rama Rao asserted that there was no engineering or design failure in the Sunkishala incident as was claimed by the Congress in the case of the Medigadda barrage. "The retaining wall between two expansion joints collapsed due to the fitting of gates in a haphazard manner, without the constant supervision of the Minister concerned. Hence, it is a complete failure on the part of the Chief Minister who also holds the Municipal Administration portfolio," he said.

Speaking to the media at Telangana Bhavan on Friday, Rama Rao pointed out that the incident occurred on August 2 when the Assembly was underway. However, the government did not make any statement in this regard which is an established practice. "Was the government attempting to hide it or was it com-

pletely unaware of it? In either case, the Chief Minister should be held responsible (as the Leader of the House) for not making the statement," he said, adding that the previous BRS government did not hide the sinking of piers at Medigadda barrage though the Assembly elections were underway. The former

MA&UD Minister stated that the accident occurred due to the fixing of gates in a haphazard manner, despite the officials advising against it and asking the government to postpone until the flood season concludes. "If there is anything good, the Congress takes credit but blames the BRS for things which go bad. They cannot escape from their responsibilities by blaming the previous BRS government," he said.

Rama Rao said the previous BRS government launched the project to meet the drinking water needs of Hyderabad for the next 50 years. The project was designed to lift water from Nagarjuna Sagar at the dead storage level (462 feet). He stated that all the works, except for motor fitting and gate fixing, were pending when the Congress came to power, but kept the works pending for nearly six months and woke up from deep slumber only after drawing flak over the drinking water crisis in Hytion before being derabad. pronounced

Further, the BRS working president pointed out that the Congress government's allegations against the Kaleshwaram Lift Irrigation Scheme (KLIS), including the Medigadda barrage, have been proved wrong as the barrage withstood a flood of 12 lakh cusecs. Further, the government is also able to pump water from the Godavari River to various reservoirs. (SEE PAGE 2)

The Supreme Court on Friday refused to postpone the NEET-PG examination scheduled for August 11, saying it can't put the ca reers of two lakh candidates in jeopardy for five students who have filed the petition. The top court dismissed a plea seeking deferment of NEET-PG which the claimed that candidates have been allocated cities that are highly inconvenient for them to reach. A Bench comprising CJI DY Chandrachud and Justices JB Pardiwala and Manoj Misra said judges are not academic experts. "How can we postpone such an exam. Mr Sanjay Hegde, nowadays people just come asking to postpone the exam. It's not a perfect world. We are not academic experts. There are two lakh students and four lakh parents who will weep over the weekend if we postpone it," it said. PTI

AI tool to detect Boy dies 20 days after dog attack malnutrition CITY BUREAU

Researchers at the IIIT-Hvderabad have come up with a new AI-based tool that promises to revolutionise the way malnutrition is detected among children.

The new smartphonebased tool, developed by researchers of Raj Reddy Centre for Technology and Society (RCTS) at IIIT-Hyderabad, represents a significant departure from the traditional practice of manual recording of measurement scales, which are prone to human errors.

The researchers have come out with two setups where the measurement can be taken with the web app using the smartphone.

IIIT-Hyd's AI-based tool promises to revolutionise the

way malnutrition is detected among children

In the first setup, by placing the smartphone over the child's head, two images are taken — one of the weighing scale reading and the other of the region directly in front of the scale (on the floor). In the second setup, with the child standing against a wall with a height chart, a photograph of the child is captured as well as
