Is HYDRAA even legal?

Provisions of GHMC Act being made applicable to areas beyond corporation limits

As the Hyderabad Disaster Response and Assets Protection Agency (HYDRAA) continues to crack the whip on structures allegedly con-structed in the full tank level areas or buffer zones of lakes and on government lands, questions are being raised over the very legal sanctity of the agency.

To begin with, the Telan-

gana Core Urban Region (TCUR) has to be notified for entrusting the task of disaster management in TCUR limits to a single agency like HYDRAA.

As per GO 99, the State government has referred to the area comprising the entire GHMC and those of Hyderabad, Rangareddy, Med-Malkajgiri Sangareddy districts up to the Outer Ring Road.

The legal hurdle in this context, according to legal experts, is that, without notifying the TCUR jurisdiction through proper legislation, the State government's reference and declaring the entire GHMC area and those within the ORR as TCUR is indefensible.

More so, with just the one reason that a disaster management mechanism was

'Agency lacks statutory backing'

HYDERABAD: Coming down heavily on the Congress government over constituting HYDRAA and conferring powers to demolish structures, Hyderabad MP Asaduddin Owaisi said the agency lacked any statutory backing. AIMIM corporators approached Mayor Gadwal Vijayalaxmi and explained to her that HYDRAA lacked any legislative or legal backing. It was under the public domain. This apart, AIMIM MLA Kousar Mohiuddin also met Chief Secretary A Santhi Kumari and raised the same issue, the AIMIM chief said at a press conference here on Sunday. Recalling his childhood days, he said there used to be a waterfall at current GHMC office location. (SEE PAGE 2)

State government declared HYDRAA as a single and unified agency for disaster management in TCUR. However, HYDRA has taken over the powers of different authorities under various legislations, including the Telangana Municipalities Act, 2019, The Telangana Panchayat Raj Act, 2018, Greater Hyderabad Municipal Corporation Act, 1955, Hyderabad Metropolitan Development Authority Act, 2008, and The Telangana Urban Areas (Development) Act, 1975.

In this case, HYDRAA's Asset Protection Wing mandate is contradictory to the agency's objectives. Also, the order does not specify and does not source any promulgated legislation or the Acts mentioned above. Generally, any agency or organisation is entrusted with powers through legislation. In HYDRAA's case, there is no such statutory or legislative backing, making things evident about 'use', or

'abuse', of power.

Interestingly, the Greater
Hyderabad Municipal Corporation Act, 1955, has its own provisions. With regard to the Enforcement Vigilance and Disaster Management (EVDM), functions were listed out by providing powers to act according to its mandate. Renaming or replacing EVDM with HY-DRAA without providing any source to the legislation, notifying the same through a Government Order is null and void, legal experts say. (SEE PAGES 2, 5)

PM calls crimes against women 'unpardonable'

Prime Minister Narendra Modi on Sunday termed crimes against women an unpardonable sin, adding the guilty should not be spared. Modi's strong remarks follow protests against the brutal rape and murder of a 31-year-old trainee doctor at Kolkata's RG Kar Hospital and the sexual abuse of two fouryear-old school girls in Bad-

lapur near Mumbai. Speaking at the 'Lakhpati Didi Sammelan' in north Maharashtra's Jalgaon, Modi said the safety of women should be a priority. "The safety of mothers, sisters, and daughters is the

country's priority. I have repeatedly raised this issue from the Red Fort. Be it any State of the country, I understand the pain and anger of my sisters and daughters," he said. Modi said that he would tell every political party and State government that crime against women is an unpardonable sin.

Whoever is guilty should not be spared, he added. "Those helping the perpetrators of crimes against women should not be spared. Be it a hospital, school, government or police station, at whatever level negligence occurs, everyone should be held accountable," he said.

BRS had limited control to act on illegal structures

The launch of a demolition arive by the Hyderabad Dis aster Response and Assets Protection Agency (HY-DRAA) has sparked questions on why the previous BRS government did not launch a similar drive to remove illegal constructions and encroachments on water bodies.

What most of those who pose these questions do not know are the limitations that the Telangana government had faced during the past decade, when Hyderabad served as the common capital for both Telangana and Andhra Pradesh.

From 2014 to 2024, Hyderabad was governed under a unique administrative arrangement established under the Andhra Pradesh Reorganisation Act of 2014. This arrangement, particularly under Sections 5 and 8, severely restricted the Telangana government's authority over the city. According to Section 5 of the Act, Hyderabad was designated as the common

capital for both Andhra Pradesh and Telangana for a period of 10 years, ending on June 2, 2024. During this time, Chandrashekhar Rao did not have unilateral control over the city, as it remained under the jurisdiction of both States. According to officials, this

unique arrangement complicated governance, especially when it came to enforcing decisions that involved private properties

Section 8 further complicated these challenges by granting the Governor of the common capital area an appointee of the Central government, with exclusive responsibilities for law and order, citizen security, and protection of property. The Governor's decisions

in these matters were final and did not require the approval of the Telangana government, including its Chief Minister and the Cabinet. The Act also mandated that the Governor be assisted by two advisors, both of whom were retired IAS and IPS officers, effectively sidelining CM from making unilateral decisions on critical urban issues, senior officials in the know of things told 'Telangana Today'. This arrangement made it nearly impossible for the BRS government to initiate measures that could have affected private properties in Hyderabad without Governor's consent. (SEE PAGE 2)

2 held in Rs 175 cr cyber fraud

Cyber fraudsters are now luring the hapless poor of Old City to open bank accounts and using them to commit cyber frauds by taking up high-value transactions and hawala operations. In the process, the fraudsters are collecting commissions for illegal transactions done through the bank accounts of the poor.

The data analysis of team TGCSB spotted numerous complaints that were reported on the National Cyber Reporting Portal against six specific bank accounts in SBI, Shamsheergunj. Thorough verification revealed that many transactions of high amounts were done through these accounts within a short period in March and April 2024, Director, TGCSB, Shikha Goel said. Sensing that the account holders were involved in large-scale cyber fraud, the TGCSB decided to launch an investigation. "Approximately 600 com-

plaints were linked to these accounts. The main fraudster, operating from Dubai, and his five associates were actively involved in luring poor people into opening bank accounts and utilising them in cyber crimes and hawala operations," said Shikha Goel.

Telegram CEO Durov held at Paris airport

The founder and CEO of popular encrypted messaging service Telegram was detained at a Paris airport, French media reported.

Pavel Durov was detained at the Paris Le Bourget airport on Saturday evening after landing in France from Azerbaijan, according to broadcasters LCI and TF1.

Mpox impacting broader demographic, says report

Monkeypox (Mpox) has once again surged to global attention and unlike the 2022 outbreak, the 2024 outbreak is impacting a broader demographic globally, a latest Lancet report has warned.

The report mentioned that with the Democratic Republic of the Congo at the epicentre of this outbreak, the virus' spread beyond Africa has raised international alarm, particularly with the "emergence of a new clade, 1b". "Health authorities are scrambling to contain the virus amid limited vaccine supplies, inadequate testing, and the need to balance responses to mulThe virus, primarily spreading through direct contact, has been reported among men, women, and children

tiple public health threats," it noted. The WHO on August 14 declared Mpox a Public Health Emergency of International Concern (PHEIC). Africa CDC Director-General Jean Kaseya also declared it a Public Health Emergency of Continental Security (PHECS). "Clade 1b of Mpox is of particular concern due to its higher transmissibility and

potential for more severe clinical outcomes," according to the report.

According to an epidemic intelligence report issued by the Africa CDC, there have been 18,737 Mpox cases (3,101 confirmed and 15.636 suspected) across 12 African countries since the beginning of the year, resulting in 541 deaths. In contrast, Africa recorded 14,838 Mpox cases (1,665 confirmed and 13,173 suspected) across seven countries, with 738 confirmed deaths, throughout 2023. Unlike the 2022 Mpox outbreak, which predominantly affected men who have sex with men, the 2024 outbreak is impacting a broader demographic.
