

The Congress on Friday released its first list of 31 candidates for the Haryana Assembly polls, fielding wrestler Vinesh Phogat from Julana. Olympians Phogat and

Bajrang Punia, who were at the forefront of the wrestlers' protest against then WFI chief and former BJP MP Brij Bhushan Sharan Singh, entered the political arena earlier in the day by joining the Congress with a vow of "not being scared or backing off".

They met Congress president Mallikarjun Kharge at his residence and later joined the party at the AICC headquarters in the presence of Congress general secretary in-charge organisation KC Venugopal and other leaders.

At the press conference during which they joined the party, Venugopal said Phogat received a showcause notice from the Railways after she met Rahul Gandhi on Wednesday.

Vexed with official apathy in clearing his crop loan, a farmer died by suicide on the Agriculture Office premises at Medchal

On Friday, Reddy, a native of Chittapur village in Dubbak mandal, arrived at the Agriculture Office in Medchal and hanged himself to a railing on the office premises. He lived in Medchal. He had secured a crop loan of Rs 1.92 lakh through APGVB.

Harassment by loan sharks drives student to suicide

Harassment by online loan app executives is suspected to have resulted in a youngster ending his life at Quthbullapur in Jeedimetla on Friday.

Bhanu Prakash (22) of Quthbullapur was pursuing a degree course at a private college in the city.

According to information available, he had borsome through loan apps for personal expenses, but failed to pay the EMIs on time.

Following this, loan app agents allegedly started harassing him and calling his family members, friends and relatives from his contact list.

Centre's share in revenue receipts dips

Officials fear this may impact funding for projects, schemes

The Central government's contribution to Telangana's revenue receipts has been steadily declining over the past 10 years — from 29.98 per cent as per actual revenue receipts in 2014-15 to just 19.79 per cent in the revised Budget estimates for


The significant drop in the Central contribution, which comprises the State's share in Central taxes and grants-in-aid, is raising serious concerns about the State's fiscal autonomy. Telangana's total revenue receipts grew from Rs 51,041.79 crore in 2014-15 to an estimated Rs 1,69,089.59 crore in 2023-24. However, during the same period, the Centre's contribution increased at a much slower pace, resulting in its percentage share declining each year, impacting the total revenue receipts.

In 2014-15, the Centre contributed Rs 15,306.59 crore, which accounted for nearly 30 per cent of the State's rev-

enue. By 2023-24, despite the absolute contribution rising to Rs 33,471.95 crore, its share in the total revenue receipts had fallen to 19.79 per cent.

Over the past decade, the State's own tax revenue (SOTR) witnessed a significant increase from Rs 29,288.38 crore in 2014-15 to Rs 1,11,798.14 crore in 2023-24. The State's share in Central taxes has also been slower, increasing from Rs 8,188.5 crore in 2014-15 to Rs

23,742.04 in 2023-24. However, the more alarming trend is the decrease in grants-in-aid, which are critical for funding State-specific projects and welfare programmes. This decline suggests a shift in the Central government's partisan approach, prioritising other

In 2014-15, grants-in-aid stood at Rs 7,118.09 crore, reaching a peak of Rs 15,471.13 crore in 2020-21 during the post-Covid era.

However, this figure sharply declined to Rs 9,729.91 crore in 2023-24. The downward trend raises questions about the sustainability of Telangana's financial planning and may compel the State to seek alternative revenue sources or increase borrowings, which would impact its fiscal health in the long run. Officials fear that the decreasing Central support may impact its ability to fund development projects and welfare schemes.
