Man murdered, buried by father, brother

BRS working president KT Rama Rao dubbed Chief Minister A Revanth Reddy's Musi padayatra in Nalgonda as a political stunt to divert attention from the Congress' long-standing neglect of the river over decades and woes of the rejuvenation project victims. He dared the latter to visit the affected families whose homes were at risk of getting demolished in Hyderabad, as part of the Musi River Rejuvenation project.

"Your padayatra is like placing the medicine far from the wound. While the victims of your Musi project are in Hyderabad, you are visiting Nalgonda," he said, holding Revanth Reddy responsible for the displacement of thousands of families under the guise of development.

In a statement, Rama Rao said instead of addressing the concerns of those whose homes were at risk, the Chief Minister was planning to displace thousands of families while organising a march far away from them.

KTR'S BIRTHDAY WISHES TO CM HAS A TWIST

HYDERABAD: In a birthday greeting to Chief Minister A Revanth Reddy, BRS working president KT Rama Rao served a sarcastic brew, complete with chai, Osmania biscuits and a cake-cutting invitation. His invitation went viral on social media, amid media reports that he had left for Malaysia to evade a speculated arrest in connection with the ongoing investigation into the alleged irregularities in the Formula-E racing event. "I'm very much in Hyderabad. Your agencies are welcome anytime. Chai, biscuits, and if they'd like to cut your birthday cake, it's on me," quipped KTR, aiming a sharp barb at the Chief Minister's recent calls for his arrest. Turning the heat on the Chief Minister's double standards, Rama Rao challenged him to act against the Megha Engineering and Infrastructures Ltd (MEIL) over the Sunkishala project wall collapse. "You, who loudly clamour for my arrest, will you dare to blacklist MEIL and arrest Krishna Reddy? Or does your courage vanish when it comes to your so-called 'Andhra Contractor'?" he asked, referring to Revanth Reddy's earlier rhetoric, branding MEIL as an "East India Company". (SEE PAGE 2)

He blamed the successive Congress and Telugu Desam governments in erstwhile Andhra Pradesh for turning the Musi river into a drainage canal, polluting it for over 60 years. "This padayatra is like shedding crocodile tears for victims of your own negligence. If you truly cared, you would apologise to the farmers and address the project's victims

directly," he added.
The BRS working president accused Revanth Reddy of prioritising commissions over commitments. "You spend days discussing the Musi 'Lootification' project with consultants, but cannot spare time to implement your election manifesto promises," he said, demanding that Revanth Reddy apologise to farmers affected by his policies.

Rama Rao also condemned the police action against BRS leaders and workers, many of whom were arrested or placed under house arrest ahead of the Chief Minister's padayatra. "This Congress government has made it a habit to stifle opposition voices through arrests. Detaining our leaders shows their fear of being questioned on corruption and unfulfilled promises," he said.

He demanded the immediate release of detained leaders, including former MLAs K Prabhakar Reddy and Chirumarthi Lingaiah, and vowed to continue questioning the Congress government's alleged cor-ruption and unfulfilled promises. "Leadership is about building, not tearing down. If you can't govern, step aside. The people of Telangana deserve better,"

ADJOURNED SINE DIE SRINAGAR: The Jammu and Kashmir Assembly witnessed a heated exchange of words between PDP legislators and National Conference members on Friday over the phrasing of the resolution passed in the House seeking restoration of the special status to the erstwhile State. It was adjourned sine die after the House passed the Motion of Thanks on Lieutenant Governor Manoj Sinha's address. PDP MLA from Pulwama Waheed Para said his party supported the resolution brought by the ruling National Conference (NC) on Wednesday but wanted to ensure that people outside do not feel there was a compromise in it. New SC Bench to decide AMU status

AMSTERDAM Young people on scooters

attacked Israeli fans in hitand-run assaults overnight after a soccer game in Amsterdam apparently fueled by calls to target Jewish people spread on social media, Dutch authorities said on Friday. Five people were treated in hospitals and dozens were arrested.

Tensions had been mounting in the Dutch capital over Israel's campaigns in Gaza and Lebanon, even before the Europa League match between Ajax and Maccabi Tel Aviv. Officials banned a planned pro-Palestinian demonstration near the stadium, and video showed a large crowd of Israeli fans chanting anti-Arab slogans en route to the game. Youths on scooters crisscrossed the city in search of Israeli fans. punching and kicking them and then fleeing to evade police. AP

The contentious legal question over Aligarh Muslim Unversity's (AMU) minor-

ity status would be decided by a new Bench, the Supreme Court held on Friday and overruled the 1967 judgement that said the university cannot be considered a minority institution since it was created by a Central law.

In a 4:3 majority verdict, a Constitution Bench headed by Chief Justice DY Chandrachud, said a legislation or an executive action that discriminated against religious or linguistic minorities in establishing or adeducational ministering institutions, was ultra vires Article 30(1) of the Constitution. Article 30 deals with the right of minorities to establish and administer educational institutions. Article 30 (1) says all minorities, whether based on religion SC overrules 1967 verdict that said univ can't be considered minority institution as it was created by **Central law**

or language, shall have the right to establish and administer educational institutions of their choice.

"The view taken in Azeez Basha (1967 verdict) that an educational institution is not established by a minority if it derives its legal character through a statute, is overruled," held the CJI, who authored the 118-page

A five-judge Constitution Bench in the S Azeez Basha v. Union of India in 1967 said AMU was a central university and could not be considered a minority

Teachers fired after 22 days of work

The State Education Department dealt a death blow to seven teachers, who qualified the DSC-2024 and were given appointment orders by Chief Minister A Revanth Reddy after they got selected for Hindi pan-dit posts, by terminating them from service after 22 days of work.

The teachers, who received letters of appointment from Revanth Reddy on October 9 in Hyderabad, were replaced by others overnight without prior intimation. They came to know about their termination when they went to their schools on Thursday and were told by the headmasters that their services were

Panicking, they rushed District Educational Officer E Somashekara Sarma, who plainly told them that according to GO MS No. 25, they did not have the requisite qualification, and hence were sacked.

DKS response on consent to CBI NEW DELHI

The Supreme Court on Friday sought response from the Karnataka government and Deputy Chief Minister DK Shivakumar on a plea filed by CBI challenging the State government's decision to withdraw its consent to the probe agency for investigating a disproportionate assets case against a Congress leader.

A Bench of Justices Surya Kant and Ujjal Bhuyan issued notices to Shivakumar and the government. The Karnataka Cabinet, headed by Chief Minister Siddaramaiah, in 2023, held that the previous BJP government's 2019 move to give consent to the CBI to investigate the DA case against Shivakumar was not in accordance with

Attacked and buried alive, yoga teacher fakes death

CHIKKABALLAPURA

A 34-year-old yoga teacher faked her death using breathing techniques and saved herself after allegedly being assaulted, strangled and then buried by a group of people who assumed she was dead, police said. Five people, including a

woman identified as Bindu and her friend named Satish Reddy who runs a detective agency in Bengaluru, have been arrested in connection with the incident, they said.

"Bindu suspected her husband of having an affair with the yoga teacher and asked Reddy to keep a tab on the woman and her proximity to him. As part of the plan, Reddy allegedly befriended the victim some three months ago on the pretext

of taking yoga classes from her and during this period, he gained her confidence," a police official said.

In her complaint, the victim alleged that on the pretext of showing some places around the city on October 23, he came to her house near Dibburahalli and took her in a car in which three other men were also present. She alleged that they took her to a secluded spot on the outskirts of the city

and allegedly stripped and assaulted her. According to her, she was

thrashed, threatened and strangled using a cable. She claimed that she played along, pretended to be unconscious and faked her death using breathing techniques. "Assuming the woman died, the accused alniaues. legedly dug a pit and covered her body with thin layers of soil because they were in a hurry and feared getting caught. But before leaving, they took away all her gold jewellery," a senior police

officer said. She claimed that she later managed to wriggle out of the pit and with the help of some villagers, got clothes and managed to reach the police station to file a complaint, he said. (SEE PAGE 2)

Mild tension in Shamshabad
