No tariff on smartphones

WASHINGTON: The Trump administration late Friday said they would exclude electronics like smartphones and laptops from reciprocal tariffs, a move that could help keep the prices down for popular consumer electronics that aren't usually made in the US. It would also benefit big tech companies like Apple and Samsung and chip makers like Nvidia. Machines used to make semiconductors are excluded.

Bills: SC sets deadline for President

Bills sent by Guv must be cleared in 3 months

For the first time, the Supreme Court has prescribed that the President should decide on the Bills reserved for her consideration by the Governor within a period of three months from the date on which such reference is received.

Four days after the top court cleared 10 Bills, which were stalled and reserved by Tamil Nadu Governor RN Ravi for the President's consideration, and set a timeline for all Governors to act on the Bills passed by the State Assemblies, the judgement running into 415 pages was uploaded on the apex court's website at 10.54 pm on Friday.

"We deem it appropriate to adopt the timeline pre-scribed by the Ministry of Home Affairs... and prescribe that the President is required to take a decision on the Bills reserved for his consideration by the Governor within a period of three months from the date on which such reference is received. "In case of any delay beyond this period, appropriate reasons would have to be recorded and conveyed to the concerned State. The States are also required to be collaborative

government expeditiously," the top court said. A bench of Justices JB Pardiwala and R Mahadevan on April 8 set aside the reservation of the 10 Bills for the President's consideration in the second round holding it as illegal, erroneous in law.

Without mincing words, the court said "where the Governor reserves a Bill for the consideration of the President and the President in turn withholds assent

thereto then, it shall be open to the State Government to assail such an action before this Court"

"The Bills, having been pending with the Governor for an unduly long period of time, and the Governor having acted with clear lack of bona fides in reserving the Bills for the consideration of the President, immediately after the pronouncement of the decision of this Court in State of Punjab (supra), are deemed to have been assented to by the Governor on the date when they were presented to him after being reconsidered.

While the risk of cardiovascular outcomes following SARS-CoV-2 infection has been reported in adults, a new study showed that children and adolescents are also likely to develop multiple cardiac signs and symptoms.

The evidence of heart disease post-Covid infection in children and adolescents is limited. The study, led by re-

searchers from the University of Pennsylvania, revealed children and adolescents remained at risk of cardiovascular disease, including higher odds of high blood pressure and heart failure, between one to six months after Covid-19

National Herald: ED to seize assets worth Rs 661 crore

NEW DELHI

The Enforcement Directorate on Saturday said it has served notices to take possession of immovable assets worth Rs 661 crore that it had attached as part of a money laundering probe linked to Congresscontrolled National Herald newspaper and the Associ-

ated Journals Limited (AJL). The federal probe agency said in a statement that it has served the relevant documents to the respective registrar of properties where the assets are located. Simultaneously, the notices have been affixed at "conspicuous part of these properties" located at Her-ald House at ITO (5A, Bahadur Shah Zafar Marg) in Delhi, in the Bandra (E) area (Plot No. 2, Survey No. 341) of Mumbai and the AJL

building located at Bisheshwar Nath Road (Property No.1) in Lucknow, Uttar Pradesh, on Friday.

The notices primarily seek vacation of the premises to be taken over by the ED. "A notice... has also been served to Jindal South West Projects Limited which occupies the 7th, 8th, and 9th floors at Herald House, Bandra (E), Mumbai, to transfer the rent/lease amount every month in favour of the director, Directorate of Enforcement,"

it said. The action has been taken under Section (8) and Rule 5(1) of the Prevention of Money Laundering Act (PMLA) that talks about the procedure of taking possession of assets attached by the ED and then confirmed by the adjudicating authority (of the PMLA).

These immovable assets worth Rs 661 crore, apart from shares of AJL worth Rs 90.2 crore, were attached by the ED in November 2023 to "secure the proceeds of crime and to prevent the accused form dissipating the same.'

The Adjudicating Authority confirmed this order in April last year. According to the ED, the total "proceeds of crime" in the case was Rs 988 crore.

The Congress had earlier termed the investigation "petty vendetta .'


Padma Shri awardee and green crusader Daripalli Ramaiah, popularly known as Vanajeevi Ramaiah, passed away on Saturday, April 12, after suffering a heart attack. He was undergoing treatment at Khammam Government Hospital. He was 88.

Ramaiah, who hailed from Reddypalli village in Khammam Rural Mandal, dedicated his entire life to planting trees and protecting the environment. In 2017, the Central Government honoured him with the Padma Shri for his tireless contribu-

tion to social forestry.He planted over one lakh saplings in and around Khammam, focusing on na-tive trees that provide shade, fruits, and biofuel. Known as Chetla Ramaiah (Trees Ramaiah), he was often seen riding his bicycle with saplings, pockets full of seeds and a deep mission to

turn barren lands green. Despite studying only till Class 10, Ramaiah read countless books on plants and became a self-taught expert. He even sold his 3 acres to buy seeds and saplings.

Chandrashekhar Rao hailed his unparalleled contributions to environmental conservation. He paid tributes to Ramaiah, who lived his life with the motto "Vruksho Rakshati Rakshitaha" (Protect trees, and they will protect you). Ramaiah's mission of planting over one crore trees and spreading awareness about the impor-

tance of greenery was described as a noble and monumental goal. The BRS chief praised Ramaiah's life as an inspiration for future

highlighting his transformation into "Vanaieevi" to nurture and protect trees. He acknowledged the extraordinary sacrifices made by Ramaiah in his lifelong dedication to the environment, calling it unmatched in human efforts for global conservation.

He also recalled the significant role Ramaiah played in supporting the Telangana

UPI faces glitch, third time in 15 days

NEW DELHI

UPI users across the country experienced transaction failures on Saturday as the popular payment system was down due to a technical glitch.

This is the third time in less than a fortnight that UPI witnessed outages impacting transactions. In the recent past, UPI outage was reported on March 26 and April 2.

According to the outage tracking platform Downdetector, a platform that monitors service disruptions based on user reports, com-

plaints about UPI failures were being received after 11:30 am.

The Unified Payments Interface (UPI) is an instant payment system developed and managed by the NPCI,

an RBI-regulated entity. NPCI acknowledged that users are facing partial transaction decline and it is working to resolve the issue. "NPCI is currently facing intermittent technical issues, leading to partial UPI transaction declines." However, the services were back to life after the technical glitch.

3 killed in Bengal clashes over Waqf Act

KOLKATA

West Bengal Chief Minister Mamata Banerjee on Saturday announced that the Waqf (Amendment) Act would not be implemented in the state, following violent protests in the Muslim-majority Murshidabad district that left at least three people dead and several others injured.

Amidst growing unrest in pockets such as Suti and Samserganj, the Calcutta High Court, acting on a petition filed by Leader of the Opposition Suvendu Ad-hikari, ordered the deployment of CAPF personnel in the affected areas.

A division bench, presided over by Justice Soumen Sen, observed that the court "cannot keep its eyes closed" when such situations arise, and stressed the need to provide adequate security to citizens.

The court also directed the Centre and the State to submit detailed reports on the situation before the next hearing on

April 17. At least three people, including a father-son duo, were killed, and over 138 arrested.
