Three-vear-old girl raped, murdered

Kambaladinne (AP) A three-year-old Dalit girl was allegedly raped and murdered here in Kadapa district by a 25year-old man, said a police official on Saturday. Additional Superintendent of Police Prakash Babu said the girl was allegedly raped and murdered by a person called Rahmatullah of Kambaladinne village in Mylavaram mandal around Friday noon. "He is in our custody," Babu told PTI. According to police, Rahmatullah came to attend a wedding and allegedly took the girl behind the function hall and raped and smothered her to death. Police booked him under the SC, ST (prevention of atrocities) Act and POCSO Act. PTI

Amarnath yatra: Security reviewed

Srinagar: Director General of Police Jammu and Kashmir Nalin Prabhat on Saturday reviewed the security arrangements for the upcoming Amarnath Yatra. Prabhat chaired a meeting with officers from the police, CRPF, ITBP, Traffic Police, Railways, and security and intelligence agencies at the Police Control Room-Kashmir. The meeting was attended by Special DGP Coordination S J M Gillani, ADGP M K Sinha, ADGP-CID Nitish Kumar, IGs of Kashmir and Jammu Zones, and IG, BSF, Kashmir. At the outset, the zonal IGsP briefed the chair on the proposed security arrangements for the conduct of Shri Amarnath Ji Yatra-2025.

Two Maoists neutralised

RAIPUR: In a significant operation against Maoist insurgents, security forces neutralised two high-ranking members of the CPI (Maoist) group in Sukma and Bijapur of Chhattisgarh. The encounters, which took place on May 22, saw a fierce exchange of fire. In the first encounter in the forests of Pesalpad, security forces found the body of a male uniformed insurgent, later identified as **Area Committee** Member Madvi Maada. Meanwhile, a second encounter took place in the Tumrel area of Bijapur, where another hardcore Maoist Sandesh alias Sannu, Area Committee Member of the South Bastar Division Committee, was eliminated. Revanth must step down or be sacked by Congress: BRS

Demands action against the CM for alleged involvement in multiple scandals

Launching a scathing attack on Chief Minister A Revanth Reddy accusing him of orchestrating large-scale corruption and turning Telangana into an "ATM for the Congress party", BRS working president KT Rama Rao on Saturday called for Reddy's immediate resignation.

Addressing a news conference at Telangana Bhavan, Rama Rao said "The ED's findings confirm what BRS has been saying for years - Revanth Reddy has been collecting massive donations for Congress in return for posts and favours,".

Referring to the ED chargesheet in the National Herald case which had named Reddy for soliciting funds, he alleged that Revanth Reddy facilitated monetary transactions into the National Herald and Young India accounts.

He drew parallels with former Karnataka Chief Minister BS Yediyurappa, who stepped down amid corruption allegations, and

demanded that Reddy follow suit or be ousted by the Congress high command. "Corruption is in the DNA of Congress. If Yediyurappa could resign, why is Revanth Reddy still clinging to power?" he questioned.

He demanded that the

Congress leadership take immediate action against him for alleged involvement in multiple corruption scandals, including the National Herald case. Rama Rao accused Reddy of maintaining a conspicuous silence when the Enforcement Directorate (ED) named Congress leaders Sonia Gandhi and Rahul Gandhi in the National Herald case, suggesting that Reddy's silence owed to his complicity in the financial irregularities.

"Almost every Congress leader responded when Sonia Gandhi and Rahul were named in the National Herald case, but Revanth Reddy chose to stay silent. He knows he was a party to it," Rama Rao alleged. He said the CM had been to Delhi as many as 44 times under various pretexts to "please his bosses- official

'Anyone can share views, ideas in BRS'

Reaffirming the BRS' commitment to internal democracy, its working president K T Rama Rao stated on Saturday that the party fostered an environment where every member, regardless of position, is free to share suggestions and ideas with the leadership.

At a press conference at Telangana Bhavan, he emphasised that while open dialogue is encouraged, internal issues should be addressed within party forums to maintain unity and discipline. "BRS is a democratic organisation imbued with the spirit of internal democracy. Anyone can share suggestions with the party chief, orally or in writing, regardless of their role," Rama Rao said. He highlighted that the party provides ample opportunities for workers, functionaries,

and office bearers to engage with the leadership, including himself, to voice their views and concerns.

Reflecting on efforts to regroup after the 2023 Telangana Assembly election defeat, Rama Rao noted that a comprehensive brainstorming session was held before the 2024 Lok Sabha elections."We conducted constituency-wise brainstorming sessions over two weeks, involving thousands of party workers and functionaries. Some spoke at length, others shared suggestions, and many wrote to the leadership with ideas on moving forward," he said.

He stressed the party's inclusive approach to rebuilding but urged that internal matters remain within party forums. "We have designated forums and office bearers for this purpose. Internal issues should stay internal, regardless of one's role in the party," he added.

Monsoon hits Kerala, earliest onset in 16 years

Kerala on Saturday, marking its earliest arrival over the Indian mainland since 2009 when it reached the southern State on May 23, the India Meteorological Department (IMD) said. Normally, the southwest

monsoon makes its onset over Kerala by June 1 and covers the entire country by July 8. It starts retreating from northwest India around September 17 and withdraws completely by October 15. The monsoon had set in

over the southern State on May 30 last year; June 8 in 2023; May 29 in 2022; June 3 in 2021; June 1 in 2020; June 8 in 2019; and May 29 in 2018, IMD data showed.

Data available since 1975 showed that the monsoon reached Kerala the earliest in 1990 (on May 19), 13 days before the usual date.

According to meteorologists, there is no direct rela-

tionship between the onset date and the total rainfall over the country during the season.

The monsoon arriving early or late in Kerala does not mean it will cover other parts of the country accordingly. It is characterised by large-scale variabilities and global, regional and local features, an IMD official

The IMD in April forecast above-normal cumulative rainfall in the 2025 monsoon season, ruling out the possibility of El Nino conditions, which are associated with below-normal rainfall in the Indian subcontinent.

According to the IMD, rainfall between 96 per cent and 104 per cent of the 50year average of 87 cm is considered 'normal'.

Rainfall less than 90 per cent of the long-period average is considered 'deficient'; between 90 per cent and 95 per cent is 'below normal': between 105 per cent and 110 per cent is 'above normal'; and more than 110 per cent is considered 'excess' precipitation. India saw 934.8 mm of rainfall in 2024, 108 per cent of the average and the

highest since 2020. PTI

'2 Covid variants active in India'

NEW DELHI

Amid reports of increasing cases of SARS-CoV-2 virus in India, data from the Indian SARS-CoV-2 Genomics Consortium (IN-SACOG), set up under the Ministry of Health and Family Welfare, showed the presence of NB.1.8.1, LF.7 descendants of JN.1 Covid variant in the country.

Data from the INSACOG showed one case of NB.1.8.1 and four instances of the LF.7 type. While NB.1.8.1 was identified in April in Tamil Nadu, four cases of LF.7 were detected in Gujarat in May.

84-year-old dies, tests Covid +ve

BENGALURU: An 84year-old-man with severe comorbidities has died in Bengaluru and his Covid-19 test results came positive on Saturday, said health officials. The man with severe comorbidities got admitted to a private hospital in Whitefield, Bengaluru, on May 13 and died on May 17. Results of Covid-19 test taken on him when he was alive came on Saturday. Pak in violation of IWT: India slams 'disinformation'

India ripped through Pakistan's "disinformation" at the UN on the Indus Waters Treaty, asserting that Islamabad violated its spirit by inflicting three wars and thousands of terror attacks on India that seek to hold hostage lives of civilians, religious harmony and economic prosperity.

"We are constrained to respond to the disinformation being carried out by the delegation of Pakistan with regard to the Indus Waters Treaty. India has always acted in a responsible manner as an upper riparian state," India's Permanent Representative to UN Ambassador Parvathaneni Harish said on Friday.

Harish was addressing the UN Security Council Arria Formula meeting organised by the Permanent Mission of Slovenia on 'Protecting Water in Armed Conflict - Protecting Civilian Lives.' Harish highlighted four aspects to expose the "disinformation" by Pakistan, which spoke about India's decision to suspend the Indus Waters Treaty.

In the wake of the horrific April 22 Pahalgam attack in Jammu and Kashmir in which 26 civilians were killed, India had decided that the Indus Waters Treaty of 1960 would be held in abeyance with immediate effect until Pakistan credibly and irrevocably abjures its support for crossborder terrorism. Harish told the UN meet-

ing that India had entered into the Indus Waters Treaty 65 years ago in good

Harish said throughout these six and a half decades, "Pakistan has violated the spirit of the treaty by inflicting three wars and thousands of terror attacks on India." PTI

LRS portal glitches leave many applicants in a bind

With six days remaining until the deadline, to avail the Land Regularisation Scheme (LRS), anxious applicants in Serilingampally are being made to run from pillar to post due to technical problems in the Centre for Good Governance-developed portal.

The deadline was recently extended by the State government till May 31 but technical glitches have come as a major hurdle leaving applicants worried about submitting the documents and completing the process within a time-

bound schedule. Kavi Raj, a property

owner in Serilingampally, has been doing the rounds at the GHMC Zonal Office in Serilingampally for the past four days. "I can't upload the original documents under the LRS scheme. The officials said they can't take the documents manually," he

told 'Telangana Today'. Kavi Raj said like him, many applicants were visiting the office and waiting for hours to complete the process.

The GHMC announced that applicants who pay regularisation and pro-rata open space charges by March 31 will receive a 25 per cent discount on these charges. However, due technical glitches, in some areas, the applicants are facing hardships due to non-functioning of the official portal.

Efforts to reach the Serilingampally town planning officials to clarify the technical problems being faced didn't yield any response.
